## Cultural Heritage

Last week RES and consultants ERM met with the Orange Local Aboriginal Land Council (LALC) and Dubbo LALC and completed a final cultural heritage walkover. Observed on the site were numerous wildlife species: Eastern Grey Kangaroos, Common Wallaroos, Shingleback Lizards, Nankeen Kestrels and Wedge-tailed Eagles. Several intact scar trees and archaeological deposits were identified on the project site. This information will inform the final design of the Project.

## Technical Assessments

The spring biodiversity and ecology surveys have now been completed and the results are being assessed by independent consultants ERM. Findings will be published as part of the Environmental Impact Statement (EIS).

## Updated NSW Wind Energy Guideline

In November the NSW Government published the updated NSW Wind Energy Guideline. The Guideline provides guidance about evaluating visual and noise impacts and information on aviation safety and other assessment issues.
